#### Ritual Committee Minutes, January 4, 2023

**D'var Torah:** The meeting began at 7:30 p.m. Rabbi Roller gave a D'var Torah.

**Minutes:** The minutes from the November 2 meeting were approved as published.

#### **Announcements:**

- (1) High Holy Days: For the First Day Rosh Hashanah, and all services of Yom Kippur, Rabbi Ohriner would like to serve as *Shaliach Tzibur* this year for the sections of the service where he previously served as cantor, (except that, he would not do Erev RH, or RH Day 2). As he would be *Shaliach Tizibur*, rather than cantor, there would not be a fee. When this matter is brought to the board, we need clarification on exactly what he will and won't be doing in the role as *Shaliach Tzibur*.
- (2) Women's Shabbat is January 28. USY Shabbat is March 11.
- (3) The next camera-free, screen-free traditional service will be held Shabbat, March 25, in the Beit Tefillah. Simultaneously the Ruach Shabbat will be held in the main sanctuary and on Zoom. It was asked, "Why aren't the screen-free traditional services more frequent than once every 3 months?" The answer is, between special events, Tot Shabbat, and various Netivot, March 25 is truly the first opening available.

#### **Business:**

#### I. Establish subcommittees to recruit and train lay leaders

For floor Gabbayim, Norm Abramovitz will gather and organize.

For service leaders, we would like to offer a series of standalone classes on leading various kinds of worship services, hopefully coordinated through the Adult Education committee. The curriculum will be designed by Michael Leitner, Iris Bendahan, Rivka Shenhav, and Rabbi Roller. The length of each particular class would vary depending on the amount of material to cover.

#### II. Torah scrolls being too heavy for many of us to lift

Most days of the year, we can avoid the heaviest scroll, because all three scrolls are needed only rarely. There was a question that maybe we could lighten the load of the heaviest scroll by replacing only the Etzim and keeping the parchment. However, this is not the case. In reality, the parchment is what makes a scroll heavy. However, replacing a donated scroll could be seen negatively by the donor's family. Besides, replacing a scroll is a low priority and costs money which we don't have. Consensus: instead of replacing Torah scrolls, we should recruit and train younger, stronger individuals to do Hagbahah.

Side point: our curiosity is piqued about Beth David's Torah scrolls. The committee would like to investigate and research the history of each, especially details on who donated each.

#### III. Attendance being low at minyanim

Ideas for boosting attendance at Zoom minyan – Greatest need is on Sunday mornings.

- (a) We request individuals from ritual committee to attend minyan whenever possible.
- (b) Remind folks with recent bereavement it's a mitzvah to come daily for 11 months.
- (c) Recruit folks from outside Beth David other local shuls without minyanim; also outside this county Santa Cruz and other areas.
- (d) Establish a tradition of minyan attendance in our synagogue culture start with once a month in-person especially on Sunday mornings.

#### IV. Ark doors left open by mistake

At times, the outer doors to the Ark in the sanctuary have been left open after services by mistake. After each service, the Floor Gabbai should take responsibility for making sure the Ark doors are closed.

#### V. Need Torah readers for Pesach

Looking ahead, Pesach is coming up. We have need for Torah/haftarah readers for Day 1, Day 2, Shabbat Chol Hamoed, Sunday Chol Hamoed, Day 7, and Day 8.
