# **New Business: Online Streaming for Shabbat and Yom Tov services:**

**Digital Streaming for Disabled Access:** The Conservative movement allows one-way electronic streaming of services, year round, according to the CJLS responsum, "The Use of a Remote Audio and Video Monitor on Shabbat and Yom Tov," (Rabbi Gordon Tucker, 1989). This is true, irrespective of any pandemic or 'perilous times.' In the case of Shabbat/Yom Tov, one-way digital streaming can be 100% automated in such a way that no manual adjustments of electronic equipment by synagogue staff would be needed during the service. In the spirit of inclusion, one-way streaming is a way to give the disabled and homebound members of our community full access to Shabbat services. It is comparable to the use of an audio loop for the hearing impaired.

Interactive Zoom in response to Covid pandemic: In contrast to one-way streaming, the agenda of tonight's meeting will be to review Beth David's use of interactive Zoom on Shabbat and Yom Tov, which due to the COVID-19 pandemic had been implemented in 2020, by Rabbi Jaymee Alpert, as Mara D'Atra, according to the principle of hora'at sha'ah, or 'perilous times.' The measures implemented at that time were intended to be temporary. (See "Streaming Services on Shabbat and Yom Tov", Rabbi Joshua Heller, 2020). It is up to Rabbi David Kunin, as Mara D'Atra, to decide when the perilous times have passed, and to decide which aspects of interactive Zoom should be discontinued, and when.

Rabbi Kunin's recommendation: Rabbi Kunin said that the time has come to move toward more normalcy, that is to move away from full interactivity on Shabbat/Yom Tov, and toward one-way streaming. The Rabbi emphasized that in so doing, it's important first to listen to as many voices in the community as possible, and make sure everyone feels heard, and no one feels forgotten or overlooked. It's important that any changes from full interactivity (which have been firmly in place for three and a half years) not be implemented *too* abruptly. If full Zoom interactivity is to be phased out, it should be done very gradually, to allow folks time to adjust.

The main implications of the Rabbi's recommendations (moving away from Zoom for services, and towards one-way streaming only) are:

- The removal of the Zoom Screen from the Bimah
- Discontinuation of online participation in services (Torah / Haftarah readers, honorees)
- Discontinuation of offering the Torah Cam stream
- Discontinuation of online participants being allowed to say a name for Refuah Schleimah
- Discontinuation of online participants being allowed to unmute for mourner's kaddish
- Discontinuation of chat feature whereby online participants can type personal messages to one another
- If we decide to use one-way streaming only, do away with the need for a zoom moderator.

**Voices in favor:** The Committee has heard from many congregants who favor getting rid of Zoom interactivity to bring the congregation more in alignment with Halachah. They don't want to appear callous, but it is felt that the needs of the disabled/homebound can be satisfactorily addressed with one-way streaming, as described above. While interactive Zoom had been welcome and a lifesaver for many people during the Covid pandemic, with over a hundred congregants relying on interactive Zoom every Shabbat, since that time, online participation has fallen off considerably. In recent months, the number of congregants who use interactive Zoom on a typical Shabbat is usually 16 or fewer, with the number turning on their cameras typically only 4 or 5 individuals. The number of online participants who unmute their microphones to say a name for Refuah Schleimah, the prayer for healing, is typically only 1 or 2. The number who unmute for mourner's kaddish on Shabbat is typically 0 or 1.

Rabbi Kunin says for congregants who favor getting rid of Zoom interactivity, the Zoom monitor on the bimah seems to be the biggest downside. Rabbi has heard from many congregants for whom seeing the monitor on the bimah is a disruption, counter to the spirit of Shabbat.

**Voices opposed:** Several congregants who participated in the discussion voiced their wish that Beth David retain Zoom interactivity. They feel that it provides them benefits that one-way streaming cannot provide, such as the sense of belonging, or the online access for their homebound elderly parents. Although not all these folks use online access every week, they appreciate knowing they have the option in case they cannot physically get to synagogue on occasion. Although they may not speak a name for Refuah Schleimah every week, they appreciate knowing they have that option. Although they may not unmute for mourner's kaddish, they value the fact that mourners have that option. The "Torah cam" is something else which people value.

The thing which some value the most is the ability to see the faces on their screens of others in the "online community," giving them a sense of belonging. What was repeated over and over was that one-way streaming tends to be not very different from watching a movie online – it is a 'cold' medium – whereas seeing each other's faces on their screens made them feel they were part of a live gathering. They valued the ability to chat with each other in real time using the Zoom chat feature, and type "Shabbat Shalom" to congregants they otherwise might not see.

It is noteworthy that no one mentioned in their top five values the ability to have their own faces visible on the TV screen by in-person congregants in the sanctuary.

Rabbi Kunin's recommendation: Having heard the comments by all participants, Rabbi Kunin thanked everyone for their input and expressed appreciation for the respectful way in which people spoke tonight. He emphasized the difficulty of the decision, and pointed out how important it is while adhering to Halachah for congregants to connect to the synagogue community with ease. When one form of access is reduced, we will need to think of alternative ways for people to connect. When changes are made, we need to make sure people are not forgotten. Rabbi Kunin is especially mindful of the hearing-impaired and their reliance upon the closed captioning. [Note: closed captioning is always provided, whether interactive or one-way].

Rabbi Kunin's recommendation at this time is to remove the Zoom monitor from the bimah on Shabbat and Yom Tov, starting September 1. The Zoom screen on the bimah seemed to be the one item which is the most negative for the traditionalist group, and for the online group, it seemed to be the one item which would be the least missed. We are going in baby steps, and will see how it goes.

In conclusion, the rabbi added, "As we move away from Zoom we must remember the lessons learned over Covid, which reminded us of the importance of connection. We therefore must redouble our efforts to connect with all members, ensuring that everyone, whether able to attend in person, or only able to watch the stream, will feel an essential and important part of our community."

**Motion:** Approval of the Ritual committee is not required for Rabbi Kunin's decision. Nevertheless, a motion was made for an advisory vote to adopt the recommendation of the Rabbi to remove the Zoom screen from the bimah on Shabbat and Yom Tov, starting September 1. The motion passed, with 9 in favor, 2 opposed, and 1 abstention.

There will be an announcement via email going to the whole congregation in the next few days explaining the new policy.

# **Announcements – Zoom Security Report:**

Last weekend, our Shabbat services were Zoom-bombed by an anonymous malicious disruptor from outside, despite the Zoom security features always in place, such as the "waiting room." Although the offending entity was expelled from the session promptly, with no long-lasting harm, we will have to do something to prevent this from happening again. The next step will be up to the I.T. committee. Most likely Beth David will go to a pre-registration-required protocol for all online events, including Shabbat services, weekday minyanim, committee meetings, board meetings, and general programming.
